

## DIRECTIONS TO TRIAL

Take US Hwy. 30, (west from I-405 or US 30 bypass from I-5), to the Sauvie Island Bridge. Cross the bridge onto Sauvie Island and continue NW Sauvie Island Rd., pass the Cracker Barrel Market on left and travel west about 2 miles. At the "Y" in the road stay left. Approximately 8.5 miles from the market you will enter the Wildlife Area where the road becomes graveled. Continue on gravel road until you see the parking area for field trial grounds (approx. 8.5 mi from the store).
